- **8.** Outline the treatment priorities and assessment methods for pregnant trauma patients.
- 9. Stabilize and begin treatment for a child with a burn.
- **10.** List critical steps in the care of a child with a burn.
- **11.** To understand the basics of pediatric head trauma.
- **12.** To learn what is life-saving brain surgery.
